Dear Ms. Coyle:

**Re: 10-Million American Inner-City Children Condemned To A “Fate Worse Than Death” And Bank of NY Argues That They Are Not Entitled To “Equal Protection Of The Law” Because That Is Not A “Holocaust”**

Gerald Cook wrote a personal check for the first 747 into Moscow following Glasnost to bring to Israel the first group of Russian Jews legally permitted to emigrate. Jerry has also served as President of several national Jewish organizations. Jerry was also my roommate throughout law school and the “best man” at my wedding.

Jerry once explained his strong support for Israel as motivated by the belief that a Holocaust could occur anywhere, including the United States, and a guaranteed (though not necessarily safe) haven is needed against the day when another Holocaust might occur.

Young and naïve at the time, I thought a Holocaust could never occur in America.

But it has!!!

10-million inner-city children are unnecessarily condemned to a “fate worse than death” and nobody cares!!!

The enclosed Petition for Certiorari filed with the U.S. Supreme Court on June 13, 2011, ends with the following list of some of Jonathan Kozol’s books because the Defendant-Respondent Bank of NY began making an unsupported factual argument at the appellate level that the “fate worse than death” faced by American inner-city children does not entitle them to the same “equal protection of the law” enjoyed by first-class American citizens because the “fate worse than death” allegedly is not a “Holocaust”:

- The Shame of the Nation: The Restoration of Apartheid Schooling in America (2005)
- Ordinary Resurrections: Children in the Years of Hope (2001)
- Amazing Grace: The Lives of Children and the Conscience of a Nation (1995)
- Savage Inequalities: Children in America’s Schools (1991)
- Rachel and Her Children (1988)
- Illiterate America (1985)
- The Night is Dark and I Am Far From Home: Political Indictment of US Public Schools (1975)
- Death at an Early Age (1967)

The enclosed 6/22/2011 letter to Mr. Kozol provides him a “heads up” on what is “going down” – that “Inner-City Holocaust and America’s ‘Apartheid’ Justice System” has (except for the last chapter) been written in his honor and in memory of John Howard Griffin, and that it is in “safe hands” awaiting free dissemination for use in universities around the world in courses on ethics, law, history, political science, international relations, philosophy, religion, etc.

Your regular reports on the U.S. Supreme Court for the PBS News Hour over the years have been very enjoyable. However, your report last evening which concluded with a summary of the Cert Petitions that the Court has accepted so far for next term was very disturbing because, in effect, you were reporting the results of the publicity that has been accorded various litigation by the 43 news-media superstars that have been requested four times over the last 11 months to shine the same spotlight on the *Goldman Sachs, et al.*, Cert Petition last year and the *Bank of NY, et al.*, petition this year that they routinely shine on, for example, any of David Boies’ cases including his current Proposition 8 litigation.

An unvarnished report would have stated that 10 million inner-city children are being condemned to a “fate worse than death” because 43 news-media superstars, by a continuing vote of 43-0 over the last 11 months, do not believe this is a “Holocaust.” And would have noted that a single dissent might have been sufficient to save them!!!

Unfortunately, you are now part of the last chapter of “Inner-City Holocaust and America’s ‘Apartheid’ Justice System.” It would be presumptuous of me to suggest that you should be guided by anything but your own conscience. However, please permit me to observe that my conscience would compel me to request the PBS News Hour to feature a report on the up-coming term of the Court shortly before it begins (which would coincide with September 26, 2011, the probable date on which the Court will decide on the Cert Petition for the inner-city children) in which I could make clear what is “going down” and I would terminate my relationship with the PBS New Hour if my request were denied.
